For graduate students seeking to join Kutztown University's community, the process typically starts several months before the desired enrollment term. The academic year deadlines for applying to graduate school vary by semester: Fall begins on August 1, Spring on December 1, and Summer on May 1. Most programs review completed applications ahead of these dates to form incoming classes or cohorts and return admissions decisions within one business week. This timeframe is recommended six to nine months prior to the deadline for transcripts, recommended six to nine months prior to the deadline for transcripts. applicants seeking F-1 visas must be prepared with additional processing time. They should allow at least May 1 for fall admission and October 1 for spring admission. For international students, available master's programs are limited based on the amount of classroom instructional time allowed by SEVIS. Transcript evaluation is mandatory, and detailed information can be found on the International Admissions page. Registration will reopen on January 8, 2025, while full-term add/drop periods occur between January 27-February 3, 2025. Additionally, there are specific registration deadlines for undergraduate and graduate students, as well as important dates like Spring Break (March 16-23, 2025) and final exams on May 12-16, 2025. To avoid confusion, a final exam schedule has been provided, taking into account courses starting at 7 a.m. have their final examinations or alternative evaluation methods scheduled during the final examination week.
